South32 is currently advocating for the need of experienced and qualified federal employees as part of the permitting process.

The Draft Forest Service EIS is set to be released on May 13th Approximately in February 2026, a final EIS will be released, which will lead to a Record of Decision, scheduled for July 2026.

The Draft Forest Service NEPA will include: The preferred alternative TSF locations The preferred alternative roadways The preferred alternative for power (power line construction or not) Preferred alternatives for water management

In the document, if the wording states 'No Action' This means that there is no change to the project as it currently operates.

Feel free to comment on the EIS, and be sure to review the alternatives and suggest if one of those works better for you and your community.

The Electrical Program is going well and will start in the fall. The first cohort will be 16 students and 3 semesters long.



ARIZONA STATE PERMITS

Hermosa has the following state permits regulating our construction and future operations:

Agency	Permit	Timing & Description
Arizona Department of Environmental Quality (ADEQ)	Class I Air Quality Permit	Issued 8/26/24. Authorizes and establishes limits on construction and operation of air emission sources.
Arizona Department of Environmental Quality	Aquifer Protection Permit (significant amendment)	Issued 2/6/25. Authorizes operation and future expansion of dry stack tailings storage facility to accommodate production tailings. Establishes limits protective of groundwater for discharges from our two water treatment plants.
Arizona Department of Environmental Quality	Arizona Pollutant Discharge Elimination System (AZPDES)	Issued 7/3/24. Establishes water quality limits for discharges of treated water to Alum Gulch and Harshaw Creek from water treatment plants.
Arizona Department of Environmental Quality	Arizona Pollutant Discharge Elimination System (AZPDES) Mining Multi-Sector General Permit for Stormwater Discharges (MSGP)	New MSGP issued 1/16/25. Authorizes discharge of treated stormwater associated with construction and operations.
Arizona Department of Water Resources (ADWR)	Permit to Appropriate Public Water	Issued 8/8/17, authorizing priority landowner water rights.
Arizona Department of Water Resources	License of Approval for Dam and Reservoir	Issued 8/15/23. Regulates safety of new dam construction for the dry stack tailings storage facility's underdrain collection pond.


Today, Hermosa holds all necessary state permits required for construction and operation.

CURRENT PROPOSALS UNDER REVIEW



1. <u>Distributed recharge basins</u> to keep more groundwater in the mountains.

2. Building a <u>permanent access road</u> to the site from SR-82 nearer to Nogales to bypass the Town of Patagonia; to be constructed in rough alignment with the proposed powerline to facilitate its maintenance and limit land disturbance.

3. Constructing a second <u>tailings storage facility</u> near the project site to accommodate long-term project life; the plan has been updated to further reduce impacts and protect sensitive species habitat.

4. UNS Energy is seeking approval to construct a <u>power line</u> across the Coronado National Forest to provide additional connectivity, reliability, and renewable energy.

ALTERNATIVES UNDER CONSIDERATION



Water discharge: other options include:

- Using Harshaw Creek exclusively;
- South32 proposed "rapid infiltration basins" in the Patagonia Mountains; and
- Additional alternates for distributed recharge

Roads/transportation: alternate transportation routes under review

Tailings storage: alternate TSF locations are being considered

Power: the alternative is to *not* build a new line; continue to power the project using on-site generators powered by compressed natural gas for the duration of the project requiring additional, two-way truck traffic

If the Forest Service ultimately selects a "no action" alternative, it would have these impacts:

- Treated groundwater would be discharged into Harshaw Creek exclusively.
- Harshaw Road and Cross Creek Connector would be used as the transportation corridor throughout the life of the project.
- No additional tailings storage facility would be constructed.
- The power line would not be constructed. Compressed natural gas would be the principal power source, requiring additional, two-way truck traffic.
- Shortened project life
