Santa Cruz Training Program

- The funds awarded were used to make the driveway at the Santa Cruz Training Program safer for users. (see slide deck for photos)
- On Friday, there will be a Parent Appreciation Day organized by the students, which will include songs and a play.
- Currently, 86 students are participating in the Santa Cruz Training Program

Community Foundation

The Community Foundation manages the South32 Hermosa Community Fund Grants Program, offering trust-based funding to support local initiatives. Key program guidelines include:

- Trust-Based Funding Approach: Funding decisions are guided by principles of transparency, collaboration, and long-term partnership with grantees.
- Equitable Distribution of Funds: To ensure broad community impact, organizations that receive funding in the June cycle are not eligible to apply again in the January cycle.
- Eligibility Requirements: Applicants must be headquartered in Santa Cruz County and hold a valid 501(c)(3) nonprofit designation.

- Local Advisory Oversight: The program's Community Advisory Board consists of members who live in Santa Cruz County, ensuring that funding decisions reflect local priorities and perspectives.

Green Valley Assistance Service

A Santa Cruz County outreach program for those who cannot afford the necessary upgrades/maintenance for their residences.

- Rebuilding together- using different funding sources to improve the lives of residents in Santa Cruz County.
- With the Hermosa fund, the program has been able to help people by paying for skilled work and using materials from other funding sources.

Santa Cruz County School Superintendent

The Office identifies program priorities to create focus on education through community collaboration. Through funding assistance, there has been success in:
